1. THE FORM ILLUSTRATED ABOVE (W.D., P.M.G. FORM NO. 19) IS TO BE USED ONLY FOR THE SENDING OF PERSONAL PARCELS. IT CANNOT BE USED TO SEND TOBACCO PRODUCTS.

2. W.D., P.M.G. FORM NO. 19 IS ISSUED EVERY SIXTY DAYS TO THE NEXT OF KIN. THE NAME AND ADDRESS OF THE NEXT OF KIN IS IMPRINTED IN THE LEFT CENTER OF THE FORM UNDER THE WORD "FROM." THIS LABEL IS TRANSFERABLE BY THE NEXT OF KIN TO ANY PERSON IF DESIRED. (SEE "A" ON THE LABEL.)

3. THE NAME AND ADDRESS OF THE PERSON ACTUALLY SENDING THE PERSONAL PARCEL MUST BE TYPED OR PRINTED IN THE THREE BLANK SPACES ON THE LABEL. (SEE "B" ON THE LABEL.) SINCE THIS LABEL IS TRANSFERABLE, THE ACTUAL SENDER OF THE PARCEL MAY BE SOMEONE OTHER THAN THE NEXT OF KIN.

4. THE NUMBER G 00000 IS A FILE CONTROL NUMBER. IT IS ASSIGNED FOR ADMINISTRATIVE PURPOSES ONLY. IT IS NOT TO BE CONFUSED WITH THE PRISONER OF WAR NUMBER.

5. YOU WILL FIND ADDITIONAL INFORMATION REGARDING PARCELS IN THE INCLOSED CIRCULAR ENTITLED, "PARCEL MAILING INSTRUCTIONS."

6. PLEASE DO NOT REQUEST ADDITIONAL LABELS. EXISTING REGULATIONS PERMIT THE ISSUANCE OF BUT ONE PARCEL LABEL TO THE NEXT OF KIN DURING A SIXTY-DAY PERIOD.

7. STRICT ADHERENCE TO THESE REGULATIONS WILL ASSURE A SPEEDIER DELIVERY OF PACKAGE AND TOBACCO PARCELS.

8. NO TAMPERING WITH THE LABELS IS PERMITTED. IN THE EVENT A LABEL IS TAMPERED WITH UNNECESSARILY, THERE IS A POSSIBILITY OF THE PARCEL BEING RETURNED BY THE POSTAL CENSOR.

1. THE W.D., P.M.G. FORM NO. 26 AS ILLUSTRATED ABOVE IS THE TOBACCO LABEL. IT IS ISSUED IN DUPLICATE EVERY SIXTY-DAY PERIOD TO THE NEXT OF KIN. EACH OF THESE LABELS AUTHORIZES THE SENDING OF A TOBACCO PARCEL AS EXPLAINED IN THE INCLOSED CIRCULAR ENTITLED "TOBACCO MAILING INSTRUCTIONS."

2. THE NAME AND ADDRESS OF THE NEXT OF KIN IS IMPRINTED IN THE LEFT CENTER OF EACH TOBACCO LABEL UNDER THE WORD "FROM." TOBACCO LABELS ARE TRANSFERABLE BY THE NEXT OF KIN TO ANY PERSON IF DESIRED.

3. DO NOT FILL IN THE BLANK SPACES AT THE RIGHT OF THE TOBACCO LABEL. THIS IS FOR THE COMPANY YOU SELECT. THE COMPANY ACTUALLY SENDING THE TOBACCO PRODUCTS TO THE PRISONER OF WAR WILL FILL IN THE BLANK SPACES.

4. THE TOBACCO COMPANIES, USING W.D., P.M.G. FORM NO. 26, HAVE AGREED TO PACK SUCH TOBACCO PRODUCTS AS YOU MAY ORDER AND MAIL THE PACKAGE DIRECT FROM THE FACTORY TO THE PRISONER OF WAR.

3. FILL IN ORDER, FORM NO. 26-A, ATTACH THIS FORM TO A TOBACCO LABEL, AND SEND THIS ORDER BLANK WITH YOUR MONEY ORDER REMITTANCE TO THE TOBACCO COMPANY.
